Please read the following conditions of application prior to completing your application form. By signing the Application Form, you are accepting these conditions of application.

APPLICATION ASSESSMENT - All applications will be assessed on: product type - product uniqueness (for our event) - stall size requirements - stall power requirements - vendor professionalism and previous experience.

The Australian Camp Oven Festival committee reserves the right to refuse any stall booking. Places are very limited, and invitations will be extended only to those stalls who the committee feels will best enhance our event. No correspondence will be entered into.

- **Proof of current public liability/product liability must accompany this application form.**
- Operational times are from **4pm Friday 1st October**, and stalls must stay in place and operational until the conclusion of the event. **No stalls are to be dismantled before 4pm Sunday**, though you are welcome to continue operating on Sunday evening if you would like, as main stage entertainment will continue until 6pm. Vendors are permitted to enter the grounds (but not operate) from Monday 27th September 2021 and no later than Friday 1st October 2021 before 4.00 pm. Vendors are not permitted to leave the grounds prior to 4pm Sunday 3rd October 2021.
- Included in the stall fee is Festival Entry for: 3 people for Food Stalls. Tickets for additional staff can be purchased at a discounted rate of \$15ea. These must be pre-purchased and cannot be purchased at the gate.
- If you are accepted, your site must be paid for by the due date that will be sent with your paperwork.- Failure to pay your site fee by the given date will mean you will forfeit your site.
- The Vendor must comply with all statutory obligations under the Workplace Health and Safety Act and any regulations made under it, Safe Food (Qld) and any regulations made under it, the Electrical Safety Act 2002 and any regulations made under it, the Dangerous Goods Safety Management Act 2001 and any regulations made under it and any applicable Advisory Standards, Industry Codes of Practice or Australian Standards which apply in Queensland.
- **ELECTRICAL EQUIPMENT OR LEADS** - ensure that all items have been INSPECTED AND TAGGED (and they are in date) by a licensed electrical contractor. No double adaptors are to be used (power boards are acceptable)
- **CAMPING** – If camping is required off of your trade site, please advise camping requirements. Alternately if camping is required at your trade site please include that area in your site requirements.
- All trade sites must be kept clean and completely free of rubbish during trading and when trade site is vacated at finish of event. Rubbish/skip bins are provided on site.
- The stallholder agrees to indemnify the organizing committee, Australian Camp Oven Festival Millmerran Inc., against all liability, claims, demands, expenses, fees, fines, penalties, suits, proceedings and actions of any kind.
- Refund on cancellations, less 10% of full fee, will only be paid if notification is made prior to 1 September 2021. After 1 September 2021 no refunds will be given.
